1. ACCIDENT

ACCIDENT DEFINITION:

Any event due to fortuitous, violent and external causes that produces objectively verifiable bodily injuries, which result in death and/or permanent disability.

INSUREDS:

Bootcamp US Students, from 18 to 25 years old

INSURED COVERAGE:

- Permanent disability due to accident: up to EUR 150.000,00 (with a deductible of 3% on disability points)
- Death due to accident: EUR 100.000,00

PREMIUM PER STUDENT:

EUR 15,00

1. ACCIDENT

OPERATIONAL SCOPE

It is assimilated to Accident:

- a) the consequences of sunstroke, heat stroke, cold stroke and electrocution;
- b) frostbite and freezing;
- c) the consequences of ingestion or absorption of substances if due to accidental causes;
- d) asphyxia of non-morbid origin;
- e) drowning;
- f) the consequences of infections due to Accidents eligible for compensation under insurance coverage, excluding in any case illnesses;
- g) poisonings caused by animal bites and insect stings;
- h) tropical diseases;
- i) the physical consequences of surgical operations or treatments made necessary for the treatment of injuries resulting from Accidents indemnifiable under the terms of the policy

2. HEALTH EXPENSES FOR FOREIGNERS RESIDING TEMPORARY IN ITALY

SUBJECT OF COVERAGE:

If the student who is traveling or staying in Italy for study reasons is recovered following an accident or sudden illness in a healthcare institution or receives treatment in a place equipped for first aid, reimbursement is expected, up to the amount of **EUR 30.000,00** per Insured Party and per insurance period, for medical and hospital expenses incurred for treatment or interventions received on site during the aforementioned trips or stays.

INSUREDS:

Bootcamp US Students, from 18 to 25 years old

INSURED COVERAGE:

- EUR 30.000,00 (deductible EUR 100,00)

PREMIUM PER STUDENT:

EUR 50,00

3. THIRD PARTIES AND GENERAL LIABILITY

SUBJECT OF COVERAGE:

Personal and direct civil liability of the students participating in the Bootcamp US for a period not exceeding 10 consecutive days, liability limited to bodily and material damage unintentionally caused to third parties in carrying out their camp activities, within the maximum policy limit of EUR 10.000.000,00 for each event and with the application of a deductible for material damage of EUR 500,00 for each event.

INSUREDS:

Bootcamp US Students, from 18 to 25 years old

INSURED LIMITS:

- EUR 10.000.000,00 each event (deductible for material damages EUR 500,00 each event)

PREMIUM PER STUDENT:

EUR 40,00
